



Waiver of Negligence and Complete Release of Liability

RELEASOR engages Home Sweet Home Dog Resort (hereinafter "RELEASEES") in the business of temporarily caring for RELEASOR'S dog(s). RELEASOR understands that in bringing RELEASOR'S dog(s) to Home Sweet Home Dog Resort, the dog(s) will engage in activities where inherent hazards exist. RELEASOR is aware of and appreciates the health risks and injuries that may result to RELEASOR's dog(s). By bringing RELEASOR'S dog(s) to Home Sweet Home Dog Resort, RELEASOR knowingly and freely assumes all such risks, both known and unknown, even if arising from the negligence of Home Sweet Home Dog Resort's officers, shareholders, volunteers, and employees (collectively "RELEASEES"). RELEASOR is voluntarily engaging in Home Sweet Home Dog Resort in dog care agrees to accept all risks of injury to RELEASOR'S person, dog(s), or property, including death.

In consideration of adequate supervision and humane care, RELEASOR, for himself or herself, his or her spouse, legal representatives, heirs and assigns, hereby releases, waives and discharges RELEASEES, from all liability to the RELEASOR, his or her spouse, legal representatives, heirs and assigns, for any and all loss or damage, including emotional distress and loss of companionship, and any claim for damages resulting from the same, on account of any injury to RELEASOR'S person, dog(s), or property, even injury resulting in death, whether caused by the negligence of RELEASEES, or otherwise, while the RELEASOR or RELEASOR'S dog(s) is on RELEASEES premises.

RELEASOR agrees to indemnify RELEASEES from any loss, liability, damage or cost RELEASEES may incur due to the presence of RELEASOR in or upon the premises of Home Sweet Home Dog Resort, whether caused by the negligence of RELEASEES, other clients, other dogs, or otherwise.

RELEASOR assumes full responsibility for the risk of bodily injury, death, or property damage due to the negligence of RELEASEES, other clients, other dogs, or otherwise while in or upon the premises of Home Sweet Home Dog Resort while engaging in grooming, boarding, day care, or other services offered by RELEASEES. Risk of bodily injury includes but is not limited to communicable illness and disease such as internal parasites, kennel cough, external parasites such as fleas and ticks, minor scratches, abrasions, skin irritation, allergic reactions, bites or tears. RELEASOR agrees that all vaccinations are current before entering Home Sweet Home Dog Resort.

RELEASOR agrees that if the state of RELEASOR'S dog's health requires professional attention, RELEASEE, in its sole discretion, may engage the services of a veterinarian of RELEASEE'S choosing, to administer medication, or give other necessary attention to the dog(s), and expenses thereof will be paid by RELEASOR.

RELEASOR releases all images of RELEASOR'S dog(s) while taken by RELEASEES at Home Sweet Home Dog Resort for any promotional, social media, or advertisement purposes.

RELEASOR agrees that any dog(s) not picked up by posted closing hours will incur charges for boarding and late pick-up fees. RELEASOR understands that any dog(s) left for ten days beyond the scheduled pick-up date without prior notification is thereby "abandoned" under the relevant Kansas state statute and will be seized by the appropriate law enforcement agency and impounded. RELEASOR remains liable for all charges incurred while dog(s) is in the care of Home Sweet Home Dog Resort.

RELEASOR agrees that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Kansas, and that if any portion of this agreement is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. RELEASOR understands and agrees that this Waiver of Negligence and Complete Release of Liability is binding on his or her heirs, assigns, personal representatives, next of kin, and legal representatives.
